

Relief for Workers

If you need to stay home because of COVID-19, there are resources for you. Please do not go into work if you are sick.

Paid Sick Leave

If you are feeling sick, you must stay home from work. There are several paid sick leave options available.

- The Families First Coronavirus Response Act (FFCRA) requires most employers to provide employees with two weeks (up to 80 hours) of paid sick leave if they are quarantined or experiencing COVID-19 symptoms. - In Rhode Island, most employees can earn up to 40 hours of sick leave as required under State law. This can be used in addition to the FFCRA leave. For more information, please visit dlt.ri.gov/documents/pdf/ls/HSFWfactsheet.pdf.
- If you don't have paid sick leave through your employer, or if you use up all of your sick time, Pandemic Unemployment Assistance (PUA) is another option. PUA is available to people with COVID-19 or caring for someone with COVID-19 — including self-employed and independent contractors.
- If you don't have symptoms, but are quarantining due to travel or because you may have come into contact with someone who has COVID-19, you still need to stay out of work until you have completed the full quarantine period. You can use FFCRA paid sick leave or PUA while you do so.
- If you're sick, but tested negative for COVID-19, you should still stay out of work until you're symptom-free. In that case, Temporary Disability Insurance (TDI) is another program available. More information is available at dlt.ri.gov/tdi/faq.

Out of Work?

If your place of business closes, or you are directed by your employer to stay home and are not being paid, you may be eligible for regular unemployment insurance (UI) and can apply for benefits through the Department of Labor and Training (DLT) at dlt.ri.gov/ui.

If your claim is related to COVID-19, please indicate that on your application. DLT is waiving the usual seven day waiting period for COVID-19 related claims.

If you are a gig economy worker, contract worker, small business owner, worker for hire, self-employed and are out of work because of COVID-19, you may be eligible for Pandemic Unemployment Assistance (PUA) and can apply at covidemergencyuibenefits.dlt.ri.gov.

Unable to Work?

If you are unable to work but your place of work remains open, or if you turn down an offer of employment, you need to have good cause in order to collect benefits. Good cause includes:

- You have tested positive for COVID-19;
- Your doctor recommends you not work because you are high-risk; or
- You are the primary caregiver for someone whose place of care is closed due to COVID-19.

If you meet one of these conditions, you should apply for Pandemic Unemployment Assistance at covidemergencybenefits.dlt.ri.gov.

Not Eligible for Public Assistance?

If you are not eligible for public benefits because of immigration status, you can receive a \$400 pre-paid, no-fee debit card.

- Households can receive \$400 per eligible adult family member.

- The Rhode Island Department of Health (RIDOH) requires employers to follow COVID-19 health and safety guidelines, such as screening for illness and requiring masks.
